1. Membership

The fifteen members of the Commission are representatives from the following countries, with terms of office beginning on 1 January and ending on 31 December of the years stated in brackets: Australia (1947-1950), Belgium (1947-1948), Brazil (1947-1948), the Byelorussian Soviet Socialist Republic (1947-1950), Canada (1947-1949), China (1947-1949), Cuba (1947-1950), Czechoslovakia (1947-1949), France (1947-1948), India (1947-1949), Norway (1947-1949), Poland (1947-1948), the Union of Soviet Socialist Republics (1947-1950), the United Kingdom (1947-1948), and the United States of America (1947-1950)..

2. Officers

In the absence of the Chairman (Dr. Ragnar Frisch, Norway) and of one Vice-Chairman (Mr. Roland Wilson, Australia), the other Vice-Chairman, Prof. Alexander P. Morozov (U.S.S.R.) presided during the second session of the Commission. Dr. Isador Lubin (U.S.A.) was the Rapporteur.

At its twenty-seventh meeting, on 5 June 1947, the Commission appointed a Sub-Commission on Employment and Economic Stability with the following membership: Mr. Leslie Galfried Melville (Australia), Mr. Jacques Belin (France), Dr. Ragnar Frisch (Norway), Dr. Oscar Lange (Poland), Mr. Alexander Danilov (U.S.S.R.), Mr. Roy Forbes Harrod (United Kingdom), and Mr. Winfield Riefler (U.S.A.).

Also at its twenty-seventh meeting, on 5 June 1947, the Commission appointed a Sub-Commission on Economic Development with the following membership: Mr. José Nunes Guimarães (Brazil), Mr. D. K. Lieu (China), Mr. Emanuel Šlechta (Czechoslovakia), Mr. Vijendra K. R. V. Rao (India), Mr. Victor Urquidi (Mexico), Prof. Alexander P. Morozov (U.S.S.R.), and Mr. Beardsley Ruml (U.S.A.).

4. Ad hoc Committees and Sub-Committees

A Sub-Committee on Provisional Rules of Procedure composed of the Byelorussian Soviet Socialist Republic, India, and the United States of America, was appointed by the Commission at its twenty-fourth meeting on 2 June 1947. The Sub-Committee met once on 2 June 1947. Dr. Isador Lubin (U.S.A.) reported to the thirtieth meeting of the Commission on 10 June 1947 (text of the report in document E/CN.1/W.20*).

A Drafting Committee composed of Belgium, the Byelorussian Soviet Socialist Republic, Canada, the United Kingdom, and the United States of America, was appointed by the Commission at its thirtieth meeting 10 June 1947, to formulate a recommendation regarding the problem of employment and economic stability. The Committee met once on 10 June 1947. Dr. Isador Lubin (U.S.A.) reported to the thirty-second meeting of the Commission on 11 June 1947 (text of the report in document E/CN.1/W.22*).
